Thank you for sending through this material. I shall contact you again regarding confirmation of proposed carry-over of £703k which as you say, is related in part, to the additional grant allocated by Transport Scotland in 2010/11, brought forward from 2011/12. I also note that the total underspend is within the terms and conditions of each item of grant-in-aid, and that the capital spend of £9,855k is £1,125k greater than the initial grant for 2010/11, and that the bulk of this overspend is in respect of the ongoing viaduct bearing replacement project.

I also note that FETA's reserve has increased during 10/11 to £6,162k, but is likely to decline during 11/12 as a result of bringing forward part of the 11/12 grant, and any overspend.
