

Overall Status:

With only 1 days work to allow scaffold strip and the subsequent substantial completion we experienced a sharp fall in temperature prohibiting the painting. We attempted to work the weekend to overcome this but were beaten. This cold spell then developed in a cycle of extreme low temperatures and snow resulting in the closure of the structure for 2 weeks.

Once access to the site was again possible we were faced with a site which was covered in grit, traffic film and salts.

At this stage cleaning was abortive due to the thaw causing large amounts of run off with further contamination cascading over the works.

The decision was taken to install additional encapsulation to allow the external heaters a chance of bringing the ambient temperature to within specification once the air temperature rose. During this stage we also pressure washed the works at the areas which were critical for painting.

The encapsulation work proved successful and the required top coat was applied last week.

Scaffold strip commenced on Friday 17th December and was due for completion Tuesday 21st.


The sever frost and snow returned over the following weekend and the resultant hard frost on Monday 20th December made accessing the scaffold for stripping impossible on the grounds of safety.

Millar Callaghan have all the elements on site and will continue to progress the works as much as possible so that only floor panel installation is outstanding for completion.

At this stage we are unable to be certain of the date of completion or access due to ongoing weather conditions but we estimate that approximately 4 to 5 days works remaining when the weather breaks.

Snagging on non critical items and paint will be a return operation in the spring at a mutually agreed time.
