

#### **Overall Status:**

Since the last report progress has been good on the paint removal and re application in the Demags. Steel work was essentially being brought to site on time or as required. Steel installation had commenced in the uppers however this has now stopped.

Due to unforeseen issues with the paint adhesion in the upper Demags, some elements of steel have been removed to allow for paint removal and further re application.

This is currently under way and is in the process of new trial applications being carried out on the primer coat.

It is anticipated that final decision on the best way forward will be made Monday / Tuesday next week. To prepare for recommencement we are looking into additional paint resources and techniques to recover the programme and maximise the weather windows at this time of year.


Some discussion has also taken place about the use of winter grade primer which would aid the project but is subject to FRB approval. If this system is not supplied by International then subject to agreement we would consider the Additional painting in the Demags as a separate activity and not covered by the International 20 year warranty but supply suitable documentation to provide a separate warranty for that manufacturer.

A full review of the programme will be undertake as soon as a conclusion is reached on the re application of the paint and the impact on the programme assessed and issued to all in advance of the monthly programme submission.

Based on the information above we are reporting on programme against revision 9 for completion but 35 days ahead of contract completion. However this needs to be reviewed next week.
